The Virginia Chapter of the National Association of Women's Gymnastics Judges (VANAWGJ) will hold the 2010 Judges Cup Invitational/Sectional on Saturday, December 11th & Sunday, December 12th at Ocean Tumblers Gymnastics in Chesapeake, VA. An invitation is extended to Level 4-10 & All Star Optional athletes. Scores from this meet may be used as an invitational or sectional qualifying score. This meet will be Capital Cup format.

****NEW** DECEMBER 2010 JUDGES CUP OFFERS EXCITING NEW FEATURES FOR ALL PARTICIPANTS:**

1 - ANY VA ATHLETE ENTERING JUDGES CUP MAY QUALIFY TO THEIR STATE MEET BY ATTENDING JUDGES CUP AND SCORING THEIR STATE MEET QUALIFYING SCORE.

**LEVEL 4'S & 5'S DO NOT NEED TO RECEIVE A SECTIONAL QUALIFYING SCORE OR COMPLETE A SECTIONAL ENTRY TO USE JUDGES CUP AS A SECTIONAL - IF THEY COMPETE IN JUDGES CUP AND RECEIVE THEIR STATE MEET QUALIFYING SCORE THEY MAY ENTER THEIR STATE MEET AT THE CONCLUSION OF THEIR JUDGES CUP SESSION.

2 - COACHES WILL RECEIVE AN OUTLINED ROUTINE EVALUATION FOR EACH OF THEIR GYMNASTS PERFORMED ROUTINES ON EACH EVENT.

3 - ENTRIES TO JUDGES CUP WILL BE ACCEPTED AS OF OCTOBER 1ST, 2010.

4 - COACHES PLEASE COME PREPARED TO ENTER YOUR STATE MEET AT THE CONCLUSION OF YOUR TEAMS FINAL SESSION. STATE ENTRY PROCEDURES WILL BE FOLLOWED. YOU MAY USE ONE CHECK FOR ALL LEVELS STATE ENTRY FEES. GYM OR PARENTS CLUB CHECK ONLY

ENTRIES:

The entry fee of \$70.00 per gymnast must be postmarked on or after October 1, 2010. Please make checks payable to Judges Cup. Emailed and Faxed entries will be accepted with a copy of your check. The hard copy and the same check must be mailed that day. This meet usually fills rapidly. If necessary, entry order will be determined by the postmarks on the envelopes.
