

VIRGINIA JUDGES' CUP 2010

PLEASE NOTE DATE CHANGE: Due to site availability Judges Cup has been moved from January 30/31 to February 27/28 2010. Mark Your Calendars!

The Virginia Chapter of the National Association of Women's Gymnastics Judges (VANAWGJ) will hold the 2010 Judges Cup Invitational/Sectional on Saturday, February 27th and Sunday February 28th 2010 at the Chesapeake Conference Center in Chesapeake, Virginia. An invitation is extended to Level 4-10 & All Star Optional athletes. Scores from this meet may be used as an invitational or sectional qualifying score. This meet will be Capital Cup format.

ENTRIES:

The entry fee of \$65.00 per gymnast must be postmarked on or after November 1, 2009. Please make checks payable to Judges Cup. Emailed and Faxed entries will be accepted with a copy of your check. The hard copy and the same check must be mailed that day. This meet usually fills rapidly. If necessary, entry order will be determined by the postmarks on the envelopes. If you plan to use this meet as a state qualifier, the sectional entry form with all necessary information (qualifying score, date, and location) must be submitted by February 8th, 2010. All sectional entry rules apply. Late sectional entries will be subject to a \$25.00 late fee per gymnast.

LATE FEES:

Invitational and Sectional entries not postmarked or faxed by February 8, 2010 are subject to the \$25.00 per gymnast late fee.

TIMES: Times will be available by February 15, 2010.

LEVEL CHANGES:

Since some athletes will change levels prior to the meet, changes may be made until December 31, 2009. Changes in level after this date are charged \$10.00 per gymnast level change fee. Please send an e-mail address and contact phone number for your club on the entry form in case we need to contact you.

ENTRIES WILL BE ACCEPTED ON OR AFTER NOVEMBER 1, 2009
